Membership Types:

1. Individual Professional/Staff - \$100.00 Annual Membership Fee

Such a member shall be a trustee, faculty member, administrator or other personnel of the Nevada System of Higher Education institutions that qualifies for membership in accordance with the WRCBAA and NCBA A Constitution and Bylaws.

2. Individual Student - \$50.00 Annual Membership Fee

The student shall be currently enrolled in an institution of higher education that qualifies for membership in accordance to the SNCBAA Constitution and Bylaws. Students shall have and enjoy all the privileges of the SNCBAA membership, except those of making motions, voting and holding office.

3. Associate - \$75.00 Annual Membership Fee

Associate membership shall be extended to any individual, organization or group that does not meet any category of the NCBA A membership, but who supports the purposes, programs and activities of the NCBA A in accordance with the NCBA A Constitution and Bylaws.

4. Retiree - \$75.00 Annual Membership Fee

Retiree membership shall be extended to any retired trustee, faculty member, administrator or other personnel of Nevada System of Higher Education institutions.
